We are committed to protecting your privacy.

This Policy indicates the type of processes that may result in data being collected about you. Your use of this website gives us the right to collect that information.

What information do we collect about you?

We collect information about you when you submit your details to us to enquire about our products or services. Website information is collected using cookies.

IP address lookup

Our company uses third parties to provide information about visitors to our websites. When you visit our websites we will record your IP address. This address will be matched against public and proprietary IP address databases to provide us with information about your visit. This information may identify the organisation to whom the IP address is registered but not individuals.

Website cookies and link tracking

Cookies allow us to provide important site functionality so you don't have to re-enter lots of information. Recruitment

Cookies

We use a combination of both session and persistent cookies.
